

# Esq: RPC 8.4(b)

 "...misconduct for a Lawyer to commit a criminal act that reflects adversely on the lawyer's honesty, trustworthiness or fitness as a lawyer in other respects."



#### Civil Rights Lawsuits

#### Types of Inappropriate Behavior

- LeeringWolf whistles
- Discussion of one's partner's sexual inadequacies
- Sexual innuendo
- Comments about women's
- "Accidentally" brushing sexual parts of the body
- Lewd and threatening
- Tales of sexual exploitation
- Inappropriate invitations (e.g., hot tub)
- Sexist jokes and cartoons
- Hostile put-downs of women
- Exaggerated, mocking "courtesy"
- Public humiliation
- Obscene phone calls
- Displaying pornography in the workplace
- Insisting that workers wear revealing clothes

## Types of Inappropriate Behavior

- Graphic descriptions of pornography
- Pressure for dates
- Sexually explicit gestures
- · Unwelcome touching and hugging
- Sexual sneak attacks (e.g., grabbing breasts or buttocks)
- Sabotaging women's workSexist and insulting graffiti
- Demanding, "Hey, baby, give me a smile"
- Inappropriate gifts (ex. lingerie)
- Hooting, sucking, lip-smacking & animal noises
- Pressing or rubbing up against the victim
- Sexual assault
- Soliciting sexual services
- Stalking
- Leaning over, invading a person's space
- Indecent exposure

#### **Codes Affecting Tax Practitioners**

- AICPA Code of Professional Conduct

   includes "Principles" and "Rules"
- CPA Law of Pennsylvania
  - -7 March 1984, Public Law 106
- CPE Regulations nnsylvania CPA Board

## PA C.L.E. Board Regulations

- 42 Pa.C.S. (following CLE Rules)
- Preamble
  - "The public properly expects that lawyers, in the practice of the law, will maintain throughout their careers certain standards of professional competence and ethical behavior...."

#### CPA Law Section 9.1

- "REVOCATION OR SUSPENSION OF CERTIFICATE, REGISTRATION OR LICENSE"
- MAY REVOKE IF:
  - > DISHONESTY
  - > FRAUD
  - > GROSS NEGLIGENCE IN THE PRACTICE OF PUBLIC ACCOUNTING
  - > DO ANYTHING IF NOT PROPERLY AUTHORIZED OR LICENSED
  - > VIOLATION OF RULE OF PROFESSIONAL CONDUCT


#### CPA Law Section 9.1

- PLEADING GUILTY
- PLEADING GUILTY
   PLEADING NOLO TO A STATE/FEDERAL FELONY OR CRIME OF DISHONESTY OR FRAUD;
   CANCELLATION, REVOCATION OR SUSPENSION OR REFUSAL TO RENEW ABILITY TO PRACTICE ANYWHERE;
- SUSPENSION OR REVOCATION TO PRACTICE BEFORE ANY STATE OR FEDERAL AGENCY;
- FAILURE TO FURNISH PROOF OF SATISFACTION OF CONTINUING EDUCATION REQUIREMENTS

- 3 month suspension, 1 year Probation

- Impersonation
- CPE classes for 2 months
- \$2,500.00 CP

#### **CPA Misconduct Provisions**

- 1. FRAUD OR DECEIT IN OBTAINING A CERT
- 2. DISHONESTY, FRAUD OR GROSS NEG IN PRAC
- 3. VIOLATION OF ANY SECTION 12
- 4. VIOLATION OF A RULE OF PROFESSIONAL CONDUCT
- 5. STATE OR FED FELONY

- 6. GUILTY W ELEMENT OF DISHONESTY, FRAUD
- 7. STATE OR FED REFUSAL TO RENEW
- 8. STATE OR FED SUSPENSION/REVOCATION

#### **Atty. Misconduct Provisions**

- 1. ATTEMPT OR VIOLATE R.P.C.
- 2. CRIM ACT (HONESTY, TRUST OR FITNESS)
- 3. CONDUCT INVOLVING DISHONESTY, FRAUD, DECEIT OR MISREPRESENTATION
- 4. PREJUDICIAL CONDUCT (ADMIN OF JUST.)
- 5. IMPLY OR STATE ABILITY TO INFLUENCE
- 6. ASSIST A JUDICIAL OFFICER IN VIOLATION OF JUDICIAL OR OTHER LAW

#### Duty to Report? Self? Others?

- ALWAYS SELF-REPORT
- "MITIGATING" CIRCUMSTANCE
- CONVICTED OF A "SERIOUS" CRIME MUST REPORT IT TO DB WITHIN 20 DAYS
- CPAs????

- Violation of the R.P.C.
- Substantial issue
- Honesty
- Trustworthiness
- Fitness
- Shall inform the D.B.

#### **Rules of Disciplinary Enforcement**

- 21 sections
- 203 (Grounds)
  - Conviction of a crime
  - Fail to appear for censure, private reprimand or informal admonition
  - Willful of any section
  - Fail to comply to an order
  - Not meeting license requirements
  - Material misrepresentation on application

#### Rules of Disciplinary Enforcement

- 204 (Discipline)
  - Disbarment
  - Suspension of < 5 years
  - Public censure w or w/o probation
  - Probation
  - Private reprimand w or w/o probation
  - Public reprimand
  - Private informal admonition
  - Revocation of license

#### Code of Civility

- 42 Pa.C.S. (following Rules of Conduct)
- "... adherence to standards of professional responsibility and civility."
- "...appearance of justice as well as dispensation..."
- Judge to Lawyers--15 duties
- Lawyers to Lawyers and Court--19 duties

#### Code of Civility

- Speak and write with respect
- No disparaging personal remarks
- No "mis" anything
- Punctual
- Talk only to Judge
- Be nice to Court personnel
- Defend dignity of Judiciary

- 42 Pa.C.S. (following Bar Admission Rules)
  - Waiver
    - When an active lawyer because of circumstances beyond his or her control, cannot in any reasonable manner meet the requirement for continuing education in any given reporting year, these rules may be waived, in whole or in part.

#### C.P.A.: Discipline Continuum

- Mandatory completion of CPE courses
- Condition of Remedial Action
- Censure or Public Reprimand
- Revoke, Suspend, Limit or Restrict

# Atty. Discipline Continuum

- Private Informal Admonition
  - · Conditions may be attached
- Private Reprimand w or w/o Probation
- Probation by the Supremes under supervision of the Board
- Public Censure by the Supreme Court w or w/o Probation
- Suspension by the Supremes for a period of not more than 5 years
- Since 2002, Public Reprimand

# Atty. Discipline Continuum

- Disbarment by the Supremes
- Revocation of an Attorney's admission or license to practice law
